- **Relationship Building, Outreach, & Presentations**
 - Commission staff served as a of the diversity panelist at the OC Sheriff's training event
 - Commission staff helped facilitate dialogue with COR-AME Church called Let's Heal Together Caucus.
 - Commission staff attended the Orange County Community Indicators Report Roll-out event.
 - Commission staff met release 2020 Hate Crimes report where 150 people attended the event.
 - Commission staff met with partner organizations to discuss ways to create internal protocol for hate crime reporting and the sharing/reviewing of hate activity data on a quarterly basis.
 - Commission staff continues to support the Anaheim Bridge Taskforce looking to initiative community building dialogues between community & Anaheim PD.

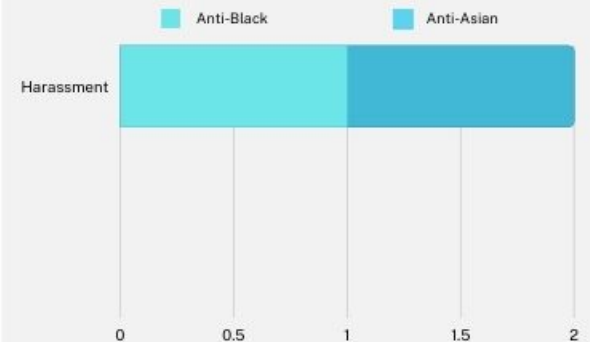
